In addition, we affirm our dedication to the attainment of these basic fundamental rights of all Education Support Professionals. This ESP Bill of Rights is established to ensure that respect, recognition, and equitable compensation are paramount in our educational institutions, thereby enhancing the overall quality of public education in Delaware.

Article I: Right to Recognition and Respect
